#### ## Proposed Constitutional Amendments

This year, there are two proposed amendment changes for the membership to consider:

#### Proposed Constitutional Amendments

Article VI: Officers Section E (Current Language) The term of office of each officer shall be two years and shall begin at the close of the Annual Convention at which he or she is elected. A one-time exception to this will be made so that the Secretary and Board Member At-Large elected at the 2000 convention will serve one year terms, these positions then being elected for two year terms again starting in 2001.

#### (Proposed Language)

The term of office of each officer shall be two years and shall begin at the close of the Annual Convention at which he or she is elected. The positions of President, Treasurer and two Board Members At Large are elected in even numbered years and the positions of Vice President, Secretary and one Board Member At Large are elected in odd numbered years. A one time exception will be made in 2010 where the positions of Vice President and Secretary elected at the 2010 convention will serve one year terms. The Vice President and Secretary positions will resume being elected for two year terms again starting in 2011.

# PROPOSED AMMENDMENT TO BLIND LGBT PRIDE INTERNATIONAL'S CONSTITUTION AND BYLAWS UNDER BYLAW 4 - AFFILIATE RESPONSIBILITIES.

(A(a) An Affiliate may be deleted from the Roster of Affiliates by a majority vote of the Board of Directors, for being more than two (2) months overdue in payment of annual dues. Blind LGBT Pride International, sets January 15<sup>th</sup> as the due date for dues collection.

(b) An Affiliate may be deleted from the Roster of Affiliates by a majority vote of the Board of Directors, for

1) Failing to supply the board with an up-to-date list of its members every year by February 15th.

2) Failing to satisfy the Board with respect to its purposes or membership.

**3**) Conducting or participating in activities contrary to the good reputation of Blind LGBT Pride International.

(c) When the Board intends to pass a motion of deletion, of an Affiliate the Affiliate concerned must be given thirty (30) calendar days notice of the intended motion and the charges on which the motion is based.

(d) Within the required thirty (30 calendar day period, the Affiliate has the right to submit answers to said charges and reasons why the motion should not pass for the Board's consideration.

(e) When a motion of deletion is passed by the Board, the Affiliate concerned has the right to appeal the action to the Board.

1) The appeal must be received by the Board within thirty (30) calendar days of the mailing of notice of deletion to the Affiliate.

2) The Membership shall vote to affirm the Board's action by a unanimous vote, or to reinstate the Affiliate by a unanimous vote.

3) The vote on the appeal shall be conducted according to the voting procedures outlined in these Bylaws, and will be held within two (2) months following the deletion vote by the board.

4) If the vote of the Board is to affirm the deletion, the deleted Affiliate will be removed from the roster of Affiliates immediately after the vote of the Board.

5) If no appeal is made, the Board's resolution to delete shall take effect thirty (30) days after its vote, and the Secretary shall enter the deletion to the roster of Affiliates and inform all Affiliates accordingly.

(E) All members of such deleted Affiliates may retain their privileges of membership in Blind LGBT Pride International and shall become Members-at-large in the case of withdrawal of their affiliate's charter.

#### **##** Doing Business on the Convention Floor

How decisions are made in General Sessions.

Convention week is crammed with activities. Among them are, usually, six sessions devoted to items of interest to the whole ACB organization. There are special speakers who give news of interest to many members. The general sessions are the times during which the business of ACG is conducted.

When ACB was formed, great attention was paid to empowering members in decisionmaking. During the general sessions, officers and board members are elected. Also, resolutions, or statements of instruction and of policy are presented for approval by members.

#### Who may vote?

Individuals who are ACB members through their paying dues to an affiliate or by paying directly to ACB as a member-at-large receive a name tag upon registering at the registration desk. That name tag will include a colored dot that indicates its holder is a voting member. Affiliates may also cast a vote.

#### How is voting conducted?

Most votes are taken by voice and the chairperson announces which side seems to have won. However, the rules allow a demand from members that that vote be taken again by calling the roll of affiliates. Some decisions must be made by roll call vote, such as elections of officers and of board members.

#### The Roll Call vote: Here's where it gets interesting.

When a vote is to be made by roll call, a standing vote is first taken. During that portion of the roll call, those wishing to vote in favor rise and tellers physically count those standing who have a dot on their name card.

Next, the name of each affiliate is called and the official delegate from that affiliate stands at a microphone and announces that affiliate's own, internal, decision. An affiliate may have assigned to it between 1 and 25 votes, depending on its number of members. Those votes may be divided in accordance with the proportion members have already stood to respond to the standing vote. Some affiliates require themselves to cast all their votes according to the majority shown in the standing vote.

A problem arises with special affiliates, such as Blind Pride. Our members may be scattered through the floor in their own state affiliate's seating. Some affiliates meet to decide in advance in what way they want their delegate to cast its vote. This is mostly done in the case of elections.

#### What does a delegate do?

The designated person should always be on the convention floor in case of the need to cast a roll call vote. If that person must miss all or part of a session, it's important that the alternate delegate be in place. If neither may be there, we must let the convention secretary at the front of the hall know whom we've designated as replacement. The person making that notification should be the delegate or alternate.

The delegate may cast the affiliate's votes, using his or her own judgment. The delegate may have been directed how to vote as a result of an earlier meeting of membeers. Blind Pride has not established an on-going policy in this matter.

#### Who is the delegate?

Some affiliates elect the delegate and alternate. Others allow the board to make the selection. In the past, people were chosen for their willingness to attend the general sessions and to perform voting duties. Blind Pride has no established policy on this matter.

## ## Board of Directors Seats Available

This year there are several seats on the Blind-LGBT-Pride Board of Directors that need to be filled. Why not consider running for one of those seats? Like any organization, Blind-LGBT-Pride needs dedicated people to keep things running for the benefit of all members. The time commitment for these volunteer positions varies somewhat, depending on the position, but generally, the board meets via conference call once a month for one or two hors. Duties such as Fund-raising, Outreach, Marketing, etc. are distributed and handled by appointed individual board members.

The positions up for election in July are: President, Vice President, Secretary, Treasurer and one Board Member at Large. The president and treasurer and Board Member-at-Large will be elected for a 2-year term. The Vice President and Secretary will, just this one time, be elected for a 1-year term. The reason for this is to insure an easy transition between administrations. This system was in place until recently when for one reason or another, positions were vacated mid term and had to be reassigned.

Interested individuals who have not already submitted a candidacy statement to the Nominating Committee can still run from the convention floor. Women are encouraged to consider running for a seat on the Board.

## ## Statements by the Candidates

Several members have expressed interest in serving on the Blind LGBT Pride Board of Directors. Below are the candidacy statements submitted by individuals who wish to be considered for a seat on the Board.

#### Candidate for President:

Hello, my name is Don Wilson. I am submitting my name as a candidate for President for the Board of Directors of Blind LGBT Pride. I have served as Secretary of this organization since July 2009. Over the past twenty years I have served on several different Board of Directors. I have served in every capacity from President to Member at Large. I have also served as a volunteer Executive Director for an all volunteer HIV/AIDS clinic. I have enjoyed volunteer work over the years. Some of the agencies I have volunteered with include American Red Cross, National Disaster Medical System DMAT, Chilton County Theatre Guild, Theatre OUTlanta, West Alabama AIDS Outreach, HIV/AIDS Consortium of West Alabama, and Fraternal Order of Police.

I currently work at AirTran Airways in the Atlanta Reservations Center. I am an Assistive Technology Specialist performing JAWS scripting and other information accessibility work. I have been with the company over three years. Before that I worked at the Center for the Visually Impaired as an Interim Assistive Technology Instructor.

## ## Another Ex-Gay Movement Leader Bites the Dust?

A South Florida gay paper is alleging that one of the national leaders of the so-called exgay movement, which purports to "cure" gays of their homosexuality, has a criminal past as a con artist.

Published as a joint investigation by the South Florida Gay News and Truth Wins Out (TWO), an organization that counters the lies of the ex-gay movement, the article contends that Arthur Goldberg, the head of JONAH (Jews Offering New Alternatives to Homosexuality), went to federal prison for 18 months as part of a plea bargain for illegal dealings on Wall Street.

Goldberg serves as president of PATH, Positive Alternatives to Homosexuality, and executive secretary of National Association for Research and Therapy of Homosexuality (NARTH), a group that believes homosexuality is a "developmental disorder" that is "treatable." "Curing" queers seems to be an obsession of Goldberg's.

K. William O'Connor, the U.S. attorney who obtained Goldberg's conviction, described him at his sentencing two decades ago as a "man who habitually took advantage of people who were economically dependent upon him." As an investment guru with Matthews & Wright, a New York-based underwriting firm, Goldberg earned the nickname "Abba Dabba Do" and called himself Arthur "Abba" Goldberg.

In his work with the ex-gay movement, according to the exposé, Goldberg does not use his middle name, "Abba." He dropped it after being released from prison. He authored a book, *Light in the Closet: Torah, Homosexuality and the Power to Change*, under the name of Arthur Goldberg.

Explained TWO founder Wayne Besen: "We have long considered Arthur Goldberg a con-artist, but our investigation shows he is also an ex-con."

"His diabolical past mirrors his dishonest present-day work with JONAH," Besen continued. "Whether it was shady deals on Wall Street or shading the truth on gay issues, Goldberg is someone who lacks credibility and can't be trusted."

The ex-gay movement also lacks credibility. Sexual orientation cannot be willed away. Ever since there's been an ex-gay movement, there've been reports of so-called ex-gays cruising in gay bars or having sex with men, even as they were professing that they were "cured" of their sexual desires.

Among the many fallen ex-gays: a poster child for the ex-gay movement (he was featured on the cover of *Newsweek*) was photographed and confronted at a gay bar in Washington. D.C. by gay activists; a founder of Homosexuals Anonymous was caught giving nude massages to men he counseled in order to "desensitize" them to homosexual sex; and a man who appears in the American Family Association's anti-gay *It's Not Gay* was found to be having unprotected sex with other men after his "cure."

Those who want to change their sexuality desperately need help accepting who they are. They don't need to be deceived into thinking they can become something they're not. As for Goldberg, it doesn't matter whether he is or isn't the same man who went to jail 20 years ago. Leading people to believe they can magically change something as basic as their sexual orientation is morally reprehensible.

## ## News Flash: LGBT Nursing Homes

The Elsie Frank House at the Leonard Florence Center for Living -- a nursing home specifically for lesbian, gay, bisexual, and transgender senior citizens -- opens this month in Chelsea, Mass.

Named for openly gay Congressman Barney Frank's mother, who had been a longtime supporter of LGBT rights at the time of her death in 2005, the home marks the nation's first Green House for LGBT elders.

"We have chosen to dedicate one of our Green Houses to the LGBT community because everyone deserves to live and receive care in a place that is filled respect for who they are, and for their dignity," Green House CEO Barry Berman told the *Golden Rainbow Times*. "Be assured that the staff at Elsie Frank have chosen to work with LGBT residents and we look forward to creating a strong sense of community in this house."

"Hannah Free" DVD Film Reviewed by Amos LassenTwo Women in Love: Sharon Gless is Hannah Free who is at an old age home and just a few feet away from her girlfriend for life, Rachel (Maureen Gallagher) who is comatose and under the guard of a homophobic daughter who will not let Hannah visit. Hannah seems to have the ability to speak to Rachel in her fantasy world but is only able to see her physically when her former college student, Greta (Jacqui Jackson), comes to visit. Greta is interested in Hannah's life story and she interviews her for a project she is working on and also sneaks her into see Rachel.

The film jumps between hospital scenes and flashbacks of the life of Hannah and Rachel. This is quite the tear-jerker of a film. We learn that Rachel was a widow and her relationship with Hannah included a lot of berating her for wanting to travel and see the world. The film looks at the treatment of the elderly, Christian proselytizing, the difference in generations, and the relations of family members to other gay family members and the issue of life support. ## ## Gay Life Around the World

Gay Life in India

The criminalization of homosexuality in India dates back to 1860, when the country was still under British rule. The statute, officially Indian Penal Code Chapter XVI, Section 377, punished "whoever voluntarily has carnal intercourse against the order of nature with any man, woman or animal." Violations are punishable by a prison term up to 10 years and possible fines.

On July 2, 2009, the New Delhi High Court, under Justice S. Muralidhar, <u>repealed</u> <u>Section 377</u>, decriminalizing consensual sex between LGBT adults.

In June of 2008, three Indian cities, <u>Bangaluru</u>, Calcutta and New Delhi, held their first LGBT pride marches just days before the Naz Foundation India Trust, an activist group, presented arguments before the New Delhi High Court to repeal Section 377. The repeal of Section 377 came just days after the second pride marches in <u>Delhi</u>, and <u>Bangalore</u>.

Gay advocacy groups argued that Section 377 had been used by Indian police to discriminate against and blackmail India's LGBT citizens. "In India, gays and lesbians still live highly closeted lives," Vikram Doctor, a member of the Queer Media Collective, told The Washington Post. "There is still violence. There are still many desperate suicides by gay couples. There is still harassment. And there is still intense pressure to marry those they do not want to be with. But today we have a voice."

It is unclear what affect the reversal of Section 377 will have on India's transgender population. *Times of India* writes, "Even if the HC [New Delhi High Court] rules in favour of transgenders [known as hijras or eunuchs] and declares Section 377 of IPC unconstitutional, it would mean little if corresponding legal rights were not conferred

on them through amendments to the Constitution, as well as personal laws, that require moving of appropriate bills in Parliament by the political class."
